1 Subject Matter Of The Processing Of Personal Data

2 Duration Of The Processing Of Personal Data

BT or its Sub-Processor will Process the Customer Personal Data for the Broadband Interlock Facility Service as set out in this Annex for as long as BT provides the Broadband Interlock Facility Service and for as long as BT may be required to Process the Customer Personal Data in accordance with Applicable Law.

3 The Nature And Purpose Of The Processing Of Personal Data

3.1 The Purpose is to provide functional access to our test platform and a means of communication with key named individuals within the customer's organisation to maintain the proper functioning of the platform and help resolve any issues with operation of the platform or test orders sent through the platform.
