

## **Q2 Online Premium Broadband Bundle Price Reduction**

1. The Online Premium Broadband Bundle Price Reduction (“**Price Reduction**”) will be available to customers who fulfil the eligibility criteria set out in Paragraphs 3 and 4 below.

### **Terms and Conditions that apply**

2. In addition to these terms, the following additional terms apply to the products eligible for this Price Reduction:

### **Eligibility**

  - b) Premium Broadband, UK Calls and Value Line Bundle; and
  - c) Premium Broadband and Line Bundle; and
  - d) Premium Broadband, UK Calls and Line Bundle.
4. The following customers are not eligible for this Price Reduction:
  - a) customers who are re-signing an existing BT Business Broadband contract (including BT Infinity);
  - b) customers who are re-grading an existing contract for BT Business Broadband (including BT Infinity);
  - c) customers who are transferring from a residential contract to a business contract; and
  - d) customers that have Fibre to the Premises.
